## Policy Regarding Gift Cards

Please note that gift cards can never be given to employees of the University and they can never be charged to an APEA. (The one exception is that Human Resources is permitted to give employees long service rewards in the form of gift certificates to the University of Regina Bookstore or MacKenzie Art Gallery).

Gift cards can be given as non-staff gifts, that is, as ‘modest tokens of appreciation to an external individual (student, visitor, volunteer, donor, host institution) in recognition of a contribution to the University.’ However, remember that non-staff gifts in the form of gift cards can’t be charged to an APEA - the CRA considers that to be a taxable benefit.

If you’re submitting a reimbursement claim for gift cards charged to a research fund, please provide supporting documentation, including a brief description of the gift and name of the gift card recipient. If at all possible, please get the recipient to sign for the card. In the case of confidential research study participants, the names can be enclosed in a sealed envelope, attached to the claim form.

If you’re unsure if you are following policy, staff will be happy to check with Financial Services for you.
